BUDGETARY ALLOCATION FOR AIRPROT DEVELOPMENT

Will the Minister of CIVIL AVIATION be pleased to state:-

- (a) the amount of budgetary allocation made to each State in the country for airport development and maintenance during the last five years;
- (b) the steps being taken by Government to improve financial assistance to States regarding the development and operation of regional airports; and
- (c) the details of financial aid provided to airports in Maharashtra for airport infrastructure development during the last five years?

ANSWER

Minister of State in the Ministry of CIVIL AVIATION (Shri Murlidhar Mohol)

(a) & (b): For revival and development of un-served and under-served airports/heliports/water-aerodromes identified under RCS-UDAN Scheme, an amount of Rs. 4500 crore in the Phase I and an amount of Rs.1000 Crores in Phase II of the Scheme has been allocated. Revival / up-gradation of unserved and underserved airports is undertaken upon its identification through valid bid and award to the Selected Airline Operator (SAO) in an UDAN bidding round.

The State wise details of Expenditure incurred on development of airports, heliports & water aerodromes in the country and the expenditure incurred in the last seven years is provided in Annexure-A.

(c): The details of expenditure incurred to develop the airports identified under the UDAN Scheme in Maharashtra are provided in Annexure-B.
