STATUS OF AMRUT SCHEME

1181. SHRI RYAGA KRISHNAIAH:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the details of on-going projects under the Atal Mission for Rejuvenation and Urban Transformation (AMRUT) in all the States, district-wise;
- (b) the number of projects implemented under the scheme during 2022-2024;
- (c) the number of project proposals pending under the scheme during the said period; and
- (d) whether Government has a mechanism to monitor projects undertaken, if so, the details thereof and, if not, the reasons therefor?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI TOKHAN SAHU)

(a) to (c): Ministry of Housing and Urban Affairs (MoHUA) is implementing Atal Mission for Rejuvenation and Urban Transformation (AMRUT), which was launched on 25 June 2015 in selected 500 cities (485 cities including 15 merged cities) and towns across the country. As reported by the State/ Union Territories (UTs), against the approved plan size of ₹77,640 crore, 6,010 projects worth ₹83,578 crore have been taken up, of which works worth ₹79,401 crore have been physically completed. City wise details of works at implementation stage is given in Annexure.

As reported by States/ UTs on AMRUT Portal, since the financial year 2022-23, 175 projects worth ₹1,716.35 crore have been awarded by the States/ UTs under AMRUT of which works worth ₹1,164.94 crore have been physically completed. There is no project proposal pending for approval under the AMRUT scheme.

(d): AMRUT guidelines have provisions for formation of State High Powered Steering Committee (SHPSC) headed by the Chief Secretary of the State, to monitor and supervise the implementation of the scheme at the State/ UT level. State Level Technical Committee (SLTC) headed by the Secretary, Urban Development & Housing Department of the State/ UT provides technical support to the SHPSC in monitoring and supervising the scheme at the State level. Further, an Apex Committee constituted under the ambit of Mission guidelines reviews and monitors the Mission periodically. For assessment and monitoring of work done under AMRUT in the States/ UTs, there is a provision of Independent Review and Monitoring Agencies (IRMAs). Funds are released to the States/ UTs upon satisfactory compliance of IRMA reports. Also, in order to fast-track the implementation of AMRUT, the progress is periodically reviewed and monitored through regular video conferences/ webinars/ workshops/ site-visits etc. by MoHUA with the States/ UTs and ULBs. There is a dedicated AMRUT online portal for tracking the progress and monitoring of projects.
