YOUTH AND WOMEN BENEFICIARIES FROM MINORITY COMMUNITIES

122. SHRI SATNAM SINGH SANDHU:

Will the Minister of MINORITY AFFAIRS be pleased to state:

- (a) details of key schemes and initiatives launched by Government to empower youth and women from minority communities, in terms of skill development, employment opportunities and educational support;
- (b) details on the number of youth and women beneficiaries from minority communities under schemes of Government, year-wise and State-wise;
- (c) steps taken to ensure these schemes reach underserved youth and women from economically weaker areas as well as efforts made to bridge the digital divide for these communities; and
- (d) details of collaborations the Central Government has established with State Governments or the private sector to expand employment opportunities for minority youth?

ANSWER

THE MINISTER OF MINORITY AFFAIRS

(SHRI KIREN RIJJU)

(a) to (d): The Government implements various schemes for the welfare and upliftment of every strata, including minorities, especially the economically weaker and lesser privileged sections of the society including youth and women. Ministry of Minority Affairs specifically implements various schemes for socio-economic and educational empowerment of the six (6) centrally notified minority communities, these schemes are implemented across the country. The Schemes/ programmes implemented by the Ministry are as under:

1. Educational Empowerment Schemes

- i. Pre-Matric Scholarship Scheme
- ii. Post Matric Scholarship Scheme
- iii. Merit-cum-Mean based Scholarship Scheme

Details of Beneficiaries and Amount Sanctioned for AY 2020-21 to 2022-23 for Scholarship Schemes are at **Annexure-I**.

2. Employment and Economic Empowerment Schemes

i) **Pradhan Mantri Virasat Ka Samvardhan (PM VIKAS)** is a central sector scheme of the Ministry converging its five erstwhile schemes namely Seekho aur Kamao, USTTAD, Nai Manzil, Nai Roshni, and Hamari Dharohar to promote inclusivity organically, by undertaking skilling and training, women leadership and entrepreneurship and education interventions for socio-economic upliftment of minorities. The scheme has four components:

- i. Skilling in modern skills and training in traditional trades
- ii. Women leadership and entrepreneurship training
- iii. Education support through open schooling/ bridge education
- iv. Infrastructure development

Additionally, the scheme will facilitate credit linkages by connecting beneficiaries with loan programs offered by the National Minorities Development & Finance Corporation (NMDFC). Beneficiaries would also be supported for market linkages through EPCH (Export Promotion Council for Handicrafts) to enhance their livelihood.

The PM VIKAS Scheme is yet to be implemented.

Year-wise and State-wise details of the number of youth and women beneficiaries from minority communities under the schemes of the Ministry is placed at **Annexure –II**. An overview of the same is as below:

ii) **National Minorities Development and Finance Corporation (NMDFC) :**

National Minorities Development & Finance Corporation (NMDFC) implements schemes of Term Loan, Micro Finance, Education Loan & Virasat Scheme to empower youth and women from minority communities by providing concessional loan for self-employment income generation ventures. The schemes of NMDFC are implemented through State Channelizing Agencies (SCAs) nominated by respective State Govt./ UT Administration, Punjab Gramin Bank and Canara Bank.

The Year-wise & State/UT wise details of number of beneficiaries including youth and women beneficiaries financed under NMDFC schemes during F.Y. 2019-20 to F.Y. 2023-24 is enclosed as “**Annexure- III**”.

All the schemes together have contributed in the acquisition of high level skills, greater opportunities in livelihood, high employability potential, improved access to better infrastructure, improved health and in the overall welfare of the Minority Communities.
