Will the Minister of **Chemicals and Fertilizers** be pleased to state:

- (a) the details of the greenfield bulk drug park projects and greenfield manufacturing plants established for the manufacturing of medical devices under the PLI scheme, State-wise, particularly in Maharashtra;
- (b) the number of projects and plants approved under the scheme for manufacturing of medical devices and drugs since the inception of the PLI scheme;
- (c) the number of projects and plants that are pending for approval with Government; and
- (d) by when the said projects would be approved?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS

- (a): Projects for establishing Greenfield bulk drug parks and production-linked incentive (PLI) for establishing Greenfield manufacturing projects for medical devices have been approved under the following schemes implemented by the Department of Pharmaceuticals:
 - (i) Scheme for Promotion of Bulk Drug Parks; and
 - (ii) Production Linked Incentive (PLI) Scheme for Promoting Domestic Manufacturing of Medical Devices ("PLI scheme for medical devices").

Greenfield bulk drug parks projects have been approved in the Bharuch district of Gujarat, Nakkapalli district of Andhra Pradesh and Una district of Himachal Pradesh, under the Scheme for Promotion for Bulk Drug Parks, and are at various stages of implementation.

Details of Greenfield manufacturing projects for medical devices that have been completed under the PLI scheme for medical devices, including the State or Union territory in which they are located, are at Annex I.

- (b): Projects for manufacturing of medical devices and drugs have been approved under the following schemes of the Department of Pharmaceuticals:
 - (i) PLI scheme for medical devices;

- (ii) PLI Scheme for Promotion of Domestic Manufacturing of critical Key Starting Materials (KSMs) / Drug Intermediates (DIs) and Active Pharmaceutical Ingredients (APIs) in India ("PLI scheme for bulk drugs"); and
- (iii) PLI scheme for Pharmaceuticals.

The number of projects approved under these PLI scheme, and the number of plants under the approved projects, are at Annex II.

(c) and (d): No applications under the aforesaid schemes are pending with the Department of Pharmaceuticals for approval.
