STORAGE CAPACITY OF FOOD CORPORATION OF INDIA

1309 SHRI DORJEE TSHERING LEPCHA:

Will the Minister of Consumer Affairs, Food and Public Distribution be pleased to state:

- (a) the storage capacity of Food Corporation of India (FCI) at present, State-wise especially in the State of Sikkim;
- (b) whether Government has increased the storage capacity of FCI in Sikkim during the last three years and the current year and if so, the details thereof;
- (c) whether FCI hires warehouses from different Central and State agencies based on the storage gap assessment and if so, the details of such agencies in Sikkim;
- (d) the amount spent on these agencies annually; and
- (e) the total quantity of foodgrains wasted in FCI's own and rented warehouses during the last three years, State/warehouse-wise?

ANSWER

- (a): Food Corporation of India (FCI) mainly stores food grains (wheat & rice) after procurement for Public Distribution System (PDS) and for maintaining buffer stock, to ensure food security in the country. As on 01.02.2025, total Covered Storage Capacity available with FCI and State agencies throughout the country for storage of Central Pool foodgrain stock is 806.94 Lakh MT. The State-wise details including Sikkim is at Annexure-I.
- (b) to (d): Requirement of Storage capacity in FCI depends upon the level of procurement, requirement of buffer norms and Public Distribution System (PDS) operations for food grains (Rice and Wheat). FCI continuously assesses and monitors the storage capacity and based on the requirement and storage gap assessment, storage capacities are created/hired through following schemes at a Pan India level including Sikkim:-

- 1. Construction of Silos under Public Private Partnership (PPP) mode
- 2. Private Entrepreneurs Guarantee (PEG) Scheme
- 3. Central Sector Scheme "Storage & Godowns"
- 4. Hiring of godown from Central Warehousing Corporation (CWC)/ State Warehousing Corporations (SWCs)/State Agencies
- 5. Private Warehousing Scheme (PWS)
- 6. Creation of godowns under Asset Monetization

A godown (510 MT) at Jorethang is hired by FCI from the Food & Civil Supplies Department, Government of Sikkim, for an annual amount of Rs.4,38,204/-.

(e): FCI mainly procures Rice, wheat and Paddy. FCI is storing & handling large quantities of foodgrains over longer period for distribution under various welfare schemes of Government. It also maintains buffer & strategic reserve for the country to ensure food security. Very negligible quantity of food grain accrued as non-issuable (damaged) mainly due to natural calamities like cyclone, flood, rain etc.

The year-wise detail of accrual of non-issuable foodgrains against the off-take handled quantity is tabled below:
