**Promotion of rural financing through NABARD**

1349. Dr. Sikander Kumar:

Will the Minister of *Finance* be pleased to state:

- (a) whether Government has given approval for setting up of new projects through NABARD across assembly constituencies in Himachal Pradesh;
- (b) if so, the details thereof;
- (c) the details of rural infrastructure development fund with project cost sanctioned during the last two years in Himachal Pradesh; and
- (d) whether Government is planning to harmonise monetary approaches through NABARD for various projects related to Agriculture, Horticulture and minor/medium irrigation sectors in Himachal Pradesh?

**Answer**

(a) to (d): The Government has taken several initiatives for development in the rural areas of Himachal Pradesh through various schemes of NABARD viz. Rural Infrastructure Development Fund (RIDF), Watershed Development Fund (WDF), Tribal Development Fund (TDF), etc.

Under RIDF, during FY 2023-24 and FY 2024-25 so far, 292 projects with total loan amount of ₹ 1931.54 crore have been sanctioned in the State. These, *inter-alia* includes 107 Rural Roads, 06 Rural Bridges, 40 Rural Drinking Water Schemes and 55 Minor/Medium Irrigation projects. The district-wise details of projects sanctioned in the State under Rural Infrastructure Development Fund (RIDF) in the last two years are given at **Annexure I**.

The details of projects sanctioned in Himachal Pradesh by NABARD through funds/ schemes other than RIDF, such as Watershed Development Fund (WDF), Tribal Development Fund (TDF) and JIVA in the last two years are given at **Annexure II**.
