(c) CPSEs under the Ministry are Board driven Commercial entities and under the guidance of their Board of Directors takes appropriate decisions for optimizing operational efficiencies, reducing operational cost and exploring new streams to sustain their profitability.

However, to support identified infrastructure projects for their operational expenditure project specific financial assistance is sometimes provided in the form of viability gap funding (VGF).
