#### USE OF AI IN CANCER TREATMENT

#### 1399. SHRI S NIRANJAN REDDY:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the total number of cancer-related hospital admissions approved under Ayushman Bharat-Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) so far and the amount spent for treatment, the State-wise distribution thereof;
- (b) the details of total number of AMRIT Pharmacy Centres currently operational across the country, State-wise;
- (c) whether Government is exploring the use of artificial intelligence (AI) in cancer diagnosis and treatment in Government hospitals, similar to initiatives taken by private medical institutions in the country; and
- (d) the steps being taken to integrate AI-driven solutions for early detection, precision treatment, and personalized cancer care within the public healthcare system?

# ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI PRATAPRAO JADHAV)

- (a): The State/UT-wise details of cancer related hospital admissions and the amount spent for treatment under Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) are at **Annexure-I**.
- (b): As on 07.03.2025, a total number of 222 AMRIT Pharmacies are there across the country, State/UT-wise details of which are at **Annexure-II**.
- (c) and (d): Ministry of Health and Family Welfare has designated AIIMS Delhi, PGIMER Chandigarh and AIIMS Rishikesh as centres of excellence for artificial intelligence. These centres are engaged in research and development of AI based solutions in health care sector which includes those on Cancer.
