# RAJYA SABHA UNSTARRED QUESTION NO-1710 ANSWERED ON -13/03/2025

### STAFF STRENGTH IN NALSA

#### 1710. SHRI MANOJ KUMAR JHA:

Will the Minister of Law and Justice be pleased to state:

- (a) whether the National Legal Services Authority (NALSA) has requested the sanction of 40 additional posts to manage its increased activities and if so, the details thereof;
- (b) the total number of sanctioned and vacant posts in NALSA as of February 2025; and
- (c) the steps being taken to fill vacant posts and ensure adequate staff strength to support NALSA's mandate and legal aid movement across the country?

### **ANSWER**

MINISTER OF STATE (INDEPENDENT CHARGE) OF THE MINISTRY OF LAW AND JUSTICE; AND MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS

- (a): NALSA has submitted a proposal for creation of 40 additional posts for NALSA. Subsequently, revised proposal has been received for creation of 46 additional posts instead of 40 posts submitted earlier. The details are at Annexure A.
- (b): There are 33 sanctioned posts at NALSA in addition to the statutory position of the Member Secretary, out of which 07 posts are vacant as on 28.02.2025.
- (c): Filling of vacant posts is an administrative matter and falls strictly under purview of NALSA. However, NALSA has been taking necessary steps to fill up the vacant posts by direct recruitment, deputation and promotion as the case may be. However, due to unavoidable circumstances including Covid-19 pandemic period, some posts of NALSA could not be filled up. To ensure adequate staff strength to support legal aid movement across the country, manpower is being hired by NALSA on contract basis apart from officers/officials attached with NALSA on diverted capacity from Supreme Court of India and other State Judicial Services.
