Will the **PRIME MINISTER** be pleased to state:

- (a) the total number of sanctioned and vacant posts of IAS/IPS and other group A services in the country, State-wise;
- (b) the number of posts of IAS/IPS that are currently vacant in Andhra Pradesh to which promotion will be done through direct recruitment and from State services and the steps being taken by the Central Government to fill these posts at the earliest;
- (c) the steps taken to increase training/capacity building institutions; and
- (d) whether State Government has made any demand to the Central Government to fill these posts?

(a) to (d): As on 01.01.2024, the total authorised strength (sanctioned) and vacant posts of Indian Administrative Service (IAS), Indian Police Service (IPS) & Indian Forest Service (IFS) officers is placed as **Annexure-A.**

Occurrence and filling up of vacancies is a continuous process. It is the endeavour of Central Government to fill a vacant post expeditiously.
