NATIONAL POLICY FOR CONSTRUCTION OF PLAYGROUNDS IN RURAL AREAS

Will the Minister of YOUTH AFFAIRS AND SPORTS be pleased to state :-

- (a) whether Government is considering implementation of a national policy to ensure the availability of playgrounds in rural areas;
- (b) the reasons for significant reduction in the budget allocated for the construction of playgrounds in 2023-24 and whether Government is planning to increase it;
- (c) whether the Ministry has a concrete mechanism to monitor the construction of rural playgrounds, if so, the details thereof; and
- (d) the number of projects approved for playground construction under MGNREGA in rural areas, particularly in Maharashtra?

(a) to (c) There is no such proposal under consideration in this Ministry. Further, 'Sports' being a State subject, the responsibility of development of sports, including construction of playgrounds, rests primarily with the respective State/Union Territory Governments. The Union Government only supplements their efforts by bridging critical gaps. The Khelo India Scheme and National Sports Development Fund (NSDF), implemented by this Ministry, under which financial assistance for development of sports infrastructure, including playgrounds, is provided, are demand-driven schemes. The details of the sports infrastructure projects approved and their sanctioned cost, funds released and their physical and financial progress, under Khelo India Scheme and NSDF, across the country, are available in public domain on the dashboards of the Ministry at https://mdsd.kheloindia.gov.in and http://www.nsdf.yas.gov.in/nsdf-glance.html.

Funds are allocated Scheme-wise and not component-wise in this Ministry. Details of funds allocated under various sports development programme of this Ministry during last five years are as under:
