(a) to (c) To create a roadmap to transform AIIMS, New Delhi, into a premier institution for Medical Research and Practice, a Committee led by Dr V K Paul, Member of NITI Aayog, has been formed. This Committee's mandate involves thoroughly examining the existing systems and processes at AIIMS and proposing significant reforms. The Terms of Reference for the Committee include identifying ways to streamline patient inflow, developing Key Performance Indicators (KPIs) to ensure optimal clinical, academic, and research outcomes, enhancing governance and transparency, and recommending strategies for financial prudence, sustainability, and self-sufficiency in managing AIIMS, New Delhi.

(d) Under Pradhan Mantri Swasthya Suraksha Yojana (PMSSY), till date 22 All India Institutes of Medical Sciences (AIIMS) has been approved in various States/UTs. Details of AIIMS, State-wise is at **Annexure.**
