PROVISION OF FACILITIES FOR TIRUPATI UNDER AMRUT

NO. 1821. SHRI YERRAM VENKATA SUBBA REDDY:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) whether 3 projects for water supply, 2 projects for sewage and septage management, 2 projects for drainage and 3 projects for development of parks have been sanctioned for Tirupati city in the State of Andhra Pradesh under AMRUT with an estimated cost of ₹209 crores;
- (b) if so, the details thereof;
- (c) whether the projects have been completed and made operational; and
- (d) if not, the reasons for delay and by when they are likely to be completed?

(a) to (d): As informed by the Government of Andhra Pradesh, under Atal Mission for Rejuvenation and Urban Transformation (AMRUT), 03 Water Supply Projects, 02 Sewerage & Septage Projects, 02 Storm Water Drainage Projects and 03 Park Projects were sanctioned in Tirupati city for an amount of ₹209.81 crores. Details of the projects under AMRUT in Tirupati city is given in Annexure. The State Government has informed that all the projects under AMRUT have been completed and operational.
