Allocation of fertilizers to Dtates

190: SHRI SAMIRUL ISLAM:

Will the Minister of **CHEMICALS AND FERTILIZERS** be pleased to state:

- (a) the details of fertilizers allotted to different States;
- (b) the details of the demand for fertilizers placed by the State Governments; and
- (c) the prices of fertilizers for the past three years (2021-2024)?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS & FERTILIZERS
(SMT. ANUPRIYA PATEL)

(a) & (b): The information regarding requirement, availability, sales and closing stock of fertilizers i.e. Urea, DAP, MOP and NPKS in the country (from 01.10.2024 to 29.01.2025) during the ongoing Rabi 2024-2025 season is placed at **Annexure – A**.

(c): The Maximum Retail Price (MRP) of Urea (exclusive of Central/State levies/GST and charges towards neem coating) for the past 3 years (2021-2024) has remained the same at Rs. 242 per 45 Kg bag. Further, The Government has implemented Nutrient Based Subsidy Policy w.e.f. 01.04.2010 for Phosphatic and Potassic (P&K) fertilizers. Under the policy, a fixed amount of subsidy, decided on annual/bi-annual basis, is provided on notified P&K fertilizers depending on their nutrient content. Under this policy, MRP is fixed by fertilizer companies as per market dynamics at reasonable level which is monitored by the Government. The details of prices of P&K fertilizers for the period 2021-2024 are placed at **Annexure-B**.
