Availability of fertilizers for farmers in India

193: DR. SASMIT PATRA:

Will the Minister of **CHEMICALS AND FERTILIZERS** be pleased to state:

- (a) total amount of fertilizers provided to the farmers of the country over the past five years, year-wise, fertilizer type-wise and State-wise;
- (b) whether there have been any complaints from farmers in the country citing lack of availability of fertilizers in the country or in specific States;
- (c) if so, the reasons for such complaints and non-availability of fertilizers;
- (d) the steps being taken to ensure that black marketing of fertilizers is not being done in the country;
- (e) with rising demand for fertilizers, how Government is planning to ensure adequate supply of the same; and
- (f) the details of production and consumption in the country?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS & FERTILIZERS

(SMT. ANUPRIYA PATEL)

(a) to (c): The availability of fertilizers during the ongoing Rabi 2024-25 season has remained adequate. Further, the information regarding demand, availability, consumption and closing stock of fertilizers across the country in last five years and in Kharif 2024 & Rabi 2024-25 season (till 29.01.2025) is placed at **Annexure – A**.

(d): Fertilizers are declared as an essential commodity under the Essential Commodities Act, 1955 and notified under Fertilizer Control Order, 1985. State Governments are empowered to take action against persons involved in black-marketing, hoarding and smuggling as per provisions of EC Act. Any complaint received at Department of Fertilizers level regarding black marketing/over-pricing of fertilizers is sent to concerned State Government to take appropriate action under Essential Commodities Act, 1955 and Fertilizer Control Order, 1985.

(e) Following steps are taken by the Government every season for ensuring timely and adequate supply of fertilizers in the country:

i. Before the commencement of each cropping season, Department of Agriculture and Farmers Welfare (DA&FW), in consultation with all the State Governments, assesses the state-wise & month-wise requirement of fertilizers.

ii. On the basis of requirement projected, Department of Fertilizers allocates adequate quantities of fertilizers to States by issuing monthly supply plan and continuously monitors the availability.

iii. The movement of all major subsidized fertilizers is monitored throughout the country by an on-line web based monitoring system called integrated Fertilizer Monitoring System (iFMS);

iv. Regular Weekly Video Conference is conducted jointly by DA&FW and D/o Fertilizers with State Agriculture Officials and corrective actions are taken to dispatch fertilizers as indicated by the State Governments.

v. The gap between demand (requirement) and production of fertilizers is met through imports. The import for the season is also finalized well in advance to ensure timely availability.

(f) The information regarding consumption of fertilizers in last 5 years and in Kharif 2024 & Rabi 2024-25 season (till 29.01.2025) is placed at **Annexure – A**, whereas the information regarding production of fertilizers in last 5 years and in FY 2024-25 (till 31.12.2024) is placed at **Annexure – B**.
