- (b) the number of cases of real estate companies that have been resolved under Corporate Insolvency solution Process (CIRP) and those which have been liquidated, the details thereof, company-wise; and
- (c) the challenges being faced by NCLT in revival of real estate projects?

- (a) & (b): As per information provided by Insolvency and Bankruptcy Board of India (IBBI), from December 2016 till December 2024, Corporate Insolvency Resolution Processes (CIRPs) have been initiated in 517 companies classified to be engaged in real estate related activities. Of these 517 cases, 229 companies have been successfully rescued through (resolution, withdrawals or closure of process) and 80 companies have ended in Liquidation. Details of these companies are at Annexure-I.
- (c): The challenges in resolving the cases in National Company Law Tribunal (NCLT) including those concerning real estate projects, inter-alia include circumstances and complexity of each case, nature of evidence, number of Interlocutory Applications (IA), stay by the higher courts, cooperation of stake holders etc.
