**YOUTH REGISTERED UNDER PMIS IN MADHYA PRADESH

- (a) the number of youth in the State of Madhya Pradesh who have completed their profile on the PMIS portal so far under the Prime Minister Internship Scheme (PMIS) as announced in the Budget 2024-25, the district-wise details thereof; and
- (b) whether the Central Government is taking any special initiative to increase the internship opportunities under PMIS scheme in the State of Madhya Pradesh, if so, the details thereof?

(a) & (b): The Prime Minister's Internship Scheme (PMIS) was announced in the Budget 2024-25. It aims to provide internship opportunities to one crore youth in top 500 companies in five years. As an initiation to this Scheme, Ministry of Corporate Affairs has launched a Pilot Project of the Scheme on 3rd October, 2024, which is targeted to provide 1.25 lakh internship opportunities to the youth in the Financial Year 2024-25. The Scheme is being implemented through an online portal <https://pminternship.mca.gov.in>.

Partner Companies for the PM Internship Scheme- Pilot Project, include the top 500 companies selected on the basis of average Corporate Social Responsibility (CSR) expenditure in the last 3 years, which covers a large number of diverse sectors including Aviation and Defence, Automotive, Banking and Financial Services, Chemical Industry, Oil, Gas and Energy etc. Further, to promote internships in emerging sectors, Scheme guidelines have a provision that any company/ bank/ financial institution desirous of participating in the Scheme may approach the Ministry of Corporate Affairs (MCA), which would take a view keeping in view underrepresented sectors.

In Round I of the PMIS Pilot Project, companies have provided around 1.27 lakh internship opportunities. In the ongoing round II of the PMIS Pilot Project more than 1.18 lakh internship opportunities (both new and edited unfilled opportunities of previous round) have been posted by the Partner Companies in 735 districts across 36 states/UTs of the country, out of which, 5220 opportunities have been provided in the state of Madhya Pradesh.

Till 12th March 2025, a total of 51,181 profiles (Round I and Round II) have been completed by the candidates from the state of Madhya Pradesh. The district-wise details is provided in the Annexure-I.
