#### ATAL PENSION YOJANA

## 1987. Shri Narayana Koragappa

Will the Minister of Finance be pleased to state:

- (a) whether any assessment has been made to find out people eligible to enroll under Atal Pension Yojana (APY);
- (b) if so, the details thereof, State-wise and in specific for Karnataka;
- (c) whether about 5.2 lakh people were enrolled under APY from Karnataka in 2023-24 and 489 about 4.5 lakhs in 2024-25;
- (d) if so, the status of enrolment since launch of scheme in May, 2015, year-wise and district-wise;
- (e) to what extent the objective of better targeting beneficiaries from October, 2022 by eliminating income tax payers, etc., helped to extend the coverage; and
- (f) the challenges faced in disbursing the benefits under APY?

#### **ANSWER**

#### MINISTER OF STATE FOR FINANCE

### (SHRI PANKAJ CHAUDHARY)

- (a) & (b) Atal Pension Yojana (APY) was launched on 09.05.2015, with the objective of creating a universal social security system for all Indians, especially the poor, the under-privileged and the workers in the unorganised sector. It is open to all citizens of India between 18-40 years of age having a savings bank account in a bank or post-office. For the outreach of the Scheme, the APY- Service Providers are encouraged to cover the eligible customer base, including the Pradhan Mantri Jan Dhan Yojana (PMJDY) account holders.
- (c) & (d) In Karnataka, 5,25,886 subscribers and 5,85,778 subscribers were enrolled during FY 2023-24 and FY 2024-25 (till 28.02.2025) respectively. Details of district-wise year-wise gross enrolments under APY, since inception, in Karnataka, is placed at Annexure A.
- (e) For better targeting of the scheme, from 01.10.2022 an income tax payer is not eligible to join APY. With the elimination of income tax payers, the APY-Service Providers such as Public Sector Banks, Private Sector Banks, Regional Rural Banks, Small Finance Banks, Payments Banks, Cooperative Banks and the Department of Posts, are more focused on covering eligible citizens under their reach, especially the poor, underprivileged, unorganised sector workers, and women under APY through all the branches situated in urban, semi-urban and rural areas.
- (f) The Scheme is currently in its accumulation phase and the first payout of pension benefits under APY shall start from 2035 onwards.
