**WOMEN BENEFICIARIES UNDER AB-PMJAY**

**2057. SMT. SULATA DEO:  
SHRI NIRANJAN BISHI:**

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the details of the States that are currently implementing the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY);
- (b) the number of Ayushman cards created in the last three years in the States where the scheme is implemented;
- (c) the number of beneficiaries under AB-PMJAY in the last three years, along with the expenditure on OPD treatments and hospital admissions, State/UT-wise;
- (d) the details of the eligibility criteria and process to provide medical benefits under AB-PMJAY; and
- (e) the number of women beneficiaries enrolled under the scheme, State/UT-wise?

**ANSWER  
THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND

- (a): As on 01.03.2025, except for West Bengal, all States/UTs across the nation have onboarded Ayushman Bharat - Pradhan Mantri Jan Arogya Yojana (AB-PMJAY).
- (b): A total number of 23.17 crore Ayushman cards have been created in the last three years (FY 2021-22 to 2023-24) in the States/UTs implementing AB-PMJAY.
- (c): AB-PMJAY provides health coverage of upto Rs. 5 lakh per family per year for secondary and tertiary care for in-patient care only i.e. hospitalization. OPD services are not covered under the scheme. State/UT-wise details of number of hospital admissions under the scheme in the last three years are at **Annexure-I**.

(d): The beneficiary families under AB-PMJAY were identified from the Socio-Economic Caste Census (SECC) of 2011 on the basis of 6 deprivation and 11 occupational criteria across rural and urban areas respectively. Further, in January 2022, on the basis of decadal growth rate of 11.7%, Government of India revised the beneficiary base to 12 crore families and provided the flexibility to States/UTs to use other databases (of similar socioeconomic profile) for verification of beneficiaries against such SECC beneficiaries who could not be identified and verified. Many of the States and Union Territories (UTs) implementing AB-PMJAY have further expanded the beneficiary base at their own cost using non-SECC data sources (including National Food Security Act, State specific datasets).

In March 2024, 37 lakh families of Accredited Social Health Activists (ASHAs), Anganwadi Workers (AWWs) and Anganwadi Helpers (AWHs) were also included in the scheme. Further, on 29.10.2024, the government expanded AB-PMJAY to provide free treatment benefits of up to ₹5 lakh per year to approximately 6 crore senior citizens aged 70 years and above, belonging to 4.5 crore families, irrespective of their socio-economic status.

(e): As on 12.03.2025, more than 18.17 crore Ayushman cards have been issued to women beneficiaries under AB-PMJAY. State/UT-wise details of number of women beneficiaries enrolled under scheme are at **Annexure-II**.
