SVAMITVA SCHEME

Will the Minister of **PANCHAYATI RAJ** be pleased to state:

(a) the number of families that have been granted land ownership under Survey of Villages Abadi and Mapping with Improvised Technology in Village Areas (SVAMITVA) Scheme, the details thereof, State-wise; and

(b) the reasons for non-implementation of the said scheme in certain States so far?

(a) As of March 13, 2025, the SVAMITVA Scheme has facilitated the preparation of 2.42 crore property cards across 1.61 lakh villages. State/Union Territory-wise details are provided in Annexure.

(b) The reasons for non-implementation of the said scheme in certain States so far are detailed below: -

A. Reasons for Non-Onboarding:

- **Bihar:** The state has an existing comprehensive land survey program under the Bihar Special Survey and Settlement Act 2011 and Rules 2012, initiated in 2013.
- West Bengal: The state possesses pre-existing "Abadi" (settlement) records. No decision has been made to implement the SVAMITVA Scheme.
- Nagaland: No decision has been made to implement the SVAMITVA Scheme.
- **Meghalaya:** Due to the presence of Autonomous District Councils (ADCs) and restrictions on private ownership of tribal land, a limited-scope MoU focusing on drone surveys was proposed. However, no decision has been conveyed by the State.
- **Chandigarh:** There are no rural local bodies in the UT and the erstwhile villages have already been mapped.

B. Reasons for Limited Pilot Implementation:

- **Tamil Nadu:** The state cited the legal validity of existing "Natham" (village site) area records, which are accepted for bank loans, as a reason for not extending the SVAMITVA Scheme.
- **Telangana:** The state is engaged in discussions with the Department of Science and Technology (DST) for a bilateral survey with the Survey of India.
- Sikkim: Due to the absence of demarcated "Abadi" land, the state has opted to restrict the scheme's scope to the Continuously Operating Reference Station (CORS) network.

C. Reasons for Implementation Suspension:

- Jharkhand: Implementation has been suspended by the Honorable Chief Minister due to perceived conflicts between property rights and provisions of the Santhal Pargana and Chhota Nagpur Tenancy Acts. Only 240 villages in Khunti district have been surveyed.
- **Manipur:** Implementation is currently on hold due to the prevailing situation in the state, with 209 villages surveyed to date.

D. Reasons for Limited Coverage:

- **Odisha:** The state has limited the survey to approximately 3,054 villages in five districts due to the availability of prior land records in other areas.
- Assam: Autonomous District Council (ADC) areas remain unsurveyed due to the inability to delineate "Abadi" land. The state has provided a list of approximately 1,074 villages in non-ADC areas for survey.
