INTERNSHIPS OFFERED AND ACCEPTED UNDER PMIS QUESTION

215. Shri Sanjay Seth:

Will the Minister of CORPORATE AFFAIRS be pleased to state:

(a) the data on internships offered and accepted during the Prime Minister Internship Scheme (PMIS), State-wise;

(b) the measures taken to ensure fair distribution of internships among youth from rural and urban areas through the scheme;

(c) the impact of the scheme in reducing regional disparities in skill development and employability;

(d) the details of the mechanisms in place to monitor the effectiveness of skill enhancement achieved through the scheme; and

(e) the feedback received from the participating companies about the quality of interns and its impact on improving the selection process of the scheme?

ANSWER

(a): The Prime Minister's Internship Scheme (PMIS) announced in the Budget 2024-25, aims to provide internship opportunities to one crore youth in top 500 companies in five years. As an initiation to this Scheme, Ministry of Corporate Affairs has launched a Pilot Project of the Scheme on 3rd October, 2024, which is targeted to provide 1.25 lakh internship opportunities in the Financial Year 2024-25. In the first round of the Pilot Project, which commenced from 3rd October, 2024, more than 1.27 lakh internship opportunities were provided by the partner companies across the country.

Against these, approximately 6.21 lakh applications were received from more than 1.81 lakh applicants. Based on the requirements sought by the Companies in the internship opportunities offered and the qualifications of the applicants, in the first round of the Pilot Project, partner companies have made 82,077 internship offers to 60,866 candidates, out of which 28,141 candidates have accepted offers to join the internship, as on 29th January, 2025. State wise

details of the number of applicants who were given offer letters and who have accepted internship in Round I of the PM Internship Pilot Project are given in Annexure I.

- (b) & (c): In round I of the PM Internship Scheme Pilot Project, about 1.27 lakh internship opportunities have been posted by the companies across 745 districts in all states/ UTs of the country. The PMIS Portal which serves as a centralized platform for end-to-end Scheme implementation and management, is accessible in 12 different languages, to enhance inclusivity from different geographical regions of the country. As per the Guidelines of the PM Internship Scheme- Pilot Project, a pool of candidates based on the number of applications received from all parts of the country, is shortlisted for each internship opportunity through the Portal by matching the qualifications of the applicants with the qualifications sought by the company for that internship opportunity. The shortlisting process is aimed at promoting diversity and social inclusivity in the internship program through providing for representation of Scheduled Castes, Scheduled Tribes, Other Backward Classes as well as Persons with Disabilities in the shortlist sent to the concerned company for further selection as per their respective processes and criterion.
- (d): As per guidelines of the scheme, a concurrent Monitoring, Evaluation and Learning (MEL) framework is also provided for to enable tracking of the outcomes as well as ensure corrective actions during the course of implementation of the pilot project. Additionally, the Ministry of Corporate Affairs (MCA) is gathering feedback from various stakeholders to analyze the scheme's impact as it continues to be implemented.
- (e): The first round of the PM Internship Scheme Pilot Project commenced on 3rd October, 2024. The process of joining of the candidates selected in the first round of the Pilot Project has commenced from December, 2024. As per Guidelines of the Pilot Project, the companies would follow their own mechanism for assessing the candidates on a periodic basis. Quarterly Assessment Report of the candidates would be uploaded by the company on the portal.
