Will the Minister of Social Justice and Empowerment be pleased to state:

- (a) the number of persons with disabilities who have been provided with assistive devices and appliances under the Assistance to Disabled Persons for Purchase/Fitting of Aids and Appliances (ADIP) scheme, State-wise;
- (b) the steps taken by Government to promote the accessibility and inclusivity of public buildings and transportation systems for persons with disabilities; and
- (c) the details of funds allocated and utilized under the scheme to support the empowerment and rehabilitation of persons with disabilities?

(a) The number of persons with disabilities who have been provided with assistive devices and appliances under the Scheme of Assistance to Persons with Disabilities for Purchase/Fittings of Aids/Appliances (ADIP Scheme) State-wise for last 03 years and current year is at Annexure-I.

(b) Department of Empowerment of Persons with Disabilities (DEPwD) launched Accessible India Campaign (Sugamya Bharat Abhiyan) as a nation-wide Campaign for achieving universal accessibility for Persons with Disabilities (PwDs) on December 3, 2015. It had three important verticals, namely – the Build Environment, the Transportation sector and Information and Communication Technology (ICT) ecosystem the objectives of which are as under :-

Part	Verticals	Objectives
A	Built Environment Accessibility:-	- Enhancing the number of accessible government buildings.
B	Transportation System Accessibility:-	- Enhancing proportion of accessible airports, enhancing the proportion of accessible Railway stations and enhancing the proportion of accessible public transport.
C	Information and Communication Eco-System Accessibility:-	Enhancing proportion of accessible and usable public documents and websites that meet internationally recognized accessibility standards, enhancing the pool of sign language interpreters, enhancing the proportion of daily captioning and sign-language interpretation of public television news programmes.

(c) the details of major schemes of the Department to support the empowerment and rehabilitation of persons with disabilities are as under:-

1. Assistance to Persons with Disabilities for Purchase/Fitting of Aids/Appliances (ADIP) Scheme.
2. Scheme for Implementation of the Rights of Persons with Disabilities Act (SIPDA).
- 3 Deendayal Divyangjan Rehabilitation Scheme (DDRS).
4. Scholarship schemes for students with disabilities.
