PM-DevINE scheme

2285 # Shri Sanjay Singh:

Will the Minister of **Development of North Eastern Region** be pleased to state:

(a) the number of projects that have been completed and still pending so far under PM-DevINE scheme, State-wise details thereof;

(b) the total amount allocated for PM-DevINE scheme from Financial Year 2022-23 to 2024-25 along with the details of the amount sanctioned and spent under the said scheme so far; and

(c) whether it is a fact that ₹2200 crore was allocated for Financial Year 2024-25, which has been reduced to ₹1394 crore in the revised estimates, if so, the reasons for this deduction in the budget?

ANSWER

The Minister of State of the Ministry of Development of North Eastern Region [Dr. Sukanta Majumdar]

(a) Since its inception in October 2022, total 36 projects worth Rs. 4927.22 crore have been sanctioned up to 28.02.2025 under Prime Minister's Development Initiative for North East Region (PM-DevINE) scheme. Out of these 36 projects, two projects worth Rs.121.21 crore have already been completed. State-wise number of these projects is at **Annexure**.

(b) PM-DevINE was announced as a new Central Sector scheme, with 100% Central funding, in the Union Budget 2022-23 and was approved by the Union Cabinet on 12 October, 2022 with a total outlay of Rs.6,600 crore for the period from 2022-23 to 2025-26. The total amounts sanctioned and that released under the scheme from 2022-23 to 2024-25 (till 28th February, 2025) are Rs.4927.22 crore and Rs.1216.53 crore, respectively.

(c) Proposals seeking release of funds are received from the State Govts/Implementing Agencies (IAs) on the basis of progress of the projects under the Scheme. Considering the proposals received from the State Govts/IAs and the pace of utilization by the States/Agencies, an RE of Rs.1394 crore, has been proposed.
