Utilization of CAMPA funds in Uttar Pradesh

2295. DR. LAXMIKANT BAJPAYEE:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) whether Government is aware that there is delay in utilisation of Compensatory Afforestation Fund Management and Planning Authority (CAMPA) funds in Uttar Pradesh and the funds are being utilised for purposes other than compensatory afforestation;
- (b) the year-wise details of CAMPA funds allocated and utilised in Uttar Pradesh in the last five years; and
- (c) the details of various projects in Uttar Pradesh in the last five years where such funds have been utilised and the amount utilised in each project?

- (a) & (b) As per information received from the State of Uttar Pradesh there is no delay in utilisation of CAMPA funds in the State. The funds are utilised for the approved activities in Annual Plan of Operations as per the Compensatory Afforestation Fund Act, 2016 and the Rules, 2018 therein framed thereunder. The details of outlay approved by National CAMPA under the various Annual Plan of Operations and amount utilised in last five years under CAMPA in State of Uttar Pradesh are given below:-
