### **DEBT BURDEN ON AGRICULTURAL WORKERS**

2408. SHRI A.A.RAHIM:

Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

(a) the details of the debt burden on agricultural workers, at present, State-wise;

(b) the details of monthly/annual income of the agricultural workers at present, State-wise;

(c) the details of the increase/decrease in the income of agricultural workers during the last five years, State-wise; and

(d) the details of financial assistance provided to agricultural workers by Government during the last five years, State-wise?

#### ANSWER

# THE MINISTER OF STATE FOR AGRICULTURE AND FARMERS WELFARE (SHRI RAMNATH THAKUR)

(a) to (c): The National Statistics Office (NSO), Ministry of Statistics and Programme Implementation (MoSPI) conducted a Situation Assessment Survey (SAS) of Agricultural Households during NSS 77th round (January, 2019 – December, 2019) with reference to the agricultural year July, 2018- June, 2019 in the rural areas of the country. As per result of SAS, the state-wise average amount of outstanding loan per agricultural households during the same period is given at **Annexure-I** and the state-wise average monthly income per agricultural household during 2018-19 is given at **Annexure-II**. However, since the last survey conducted in 2019, updated figures on the average monthly income per agricultural household is unavailable.

(d): Government of India is implementing various Central Sector and Centrally Sponsored Schemes providing financial assistance to agricultural workers which includes Pradhan Mantri Kisan Samman Nidhi (PM-KISAN), Pradhan Mantri Fasal Bima Yojana (PMFBY), Agriculture Infrastructure Fund (AIF), Modified Interest Subvention Scheme (MISS), Per Drop More Crop (PDMC), among others. List of Central Sector and Centrally Sponsored Schemes being implemented by Department of Agriculture & Farmers Welfare (DA&FW) is given in **Annexure III**. However, beneficiary details are not maintained centrally.
