### REVIEW OF PM GATI SHAKTI YOJANA

#### 2446. SHRI G.C. CHANDRASHEKHAR:

Will the Minister of **Commerce and Industry** be pleased to state:

- (a) whether it is a fact that Government has launched PM Gati Shakti Yojana to increase business environment, competitiveness and reduce logistic costs in the country;
- (b) if so, the details thereof;
- (c) whether Government has conducted any assessment/review to find out the achievement of the PM Gati Shakti Yojana in the country; and
- (d) if so, the details thereof, State-wise and year-wise?

### **ANSWER**

## THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE & INDUSTRY (SHRI JITIN PRASADA)

- (a) & (b): PM GatiShakti National Master Plan (PMGS NMP) is a transformative approach for the integrated planning of multimodal infrastructure, last mile connectivity and ensuring the seamless movement of people and goods. Central to this initiative is a GIS-based portal (PMGS NMP) that facilitates comprehensive asset mapping by Infrastructure, Social and Economic Ministries/ Departments. As on date, 36 States/UTs and 44 Central Ministries including 8 Infrastructure, 16 Social, 15 Economic Ministries, have been on-boarded on PMGS NMP. By integrating data layers from Infrastructure, Social, and Economic Ministries, PMGS NMP enables integrative infrastructure planning, informed decision-making, and Whole of Government Approach for accelerating the Nation's development.
- (c) & (d): A detailed assessment of PMGS NMP has been done for its adoption and impact across various Central Ministries and States/UTs.

The Impact assessment was carried out based on a framework designed in alignment with the six pillars of PM GatiShakti. Project and perception-based inputs were gathered via surveys/ interactions by a third party. 19 States/UTs responded to the survey. The report was submitted in May 2024. The findings are summarised below:

### **Institutional Adoption & Utilization**

- 15 States/UTs have mapped more than 24, out of 30 mandatory data layers, improving infrastructure integration.
- More than 2900 users actively utilize the PM GatiShakti portal for project planning.
- 13 States/UTs implemented Quality Improvement Plans (QIP) and adopted Standard Operating Procedures (SOPs).

- 10 States/UTs regularly update data layers, ensuring real-time insights and coordination.
- All 36 States/UTs have established Empowered Group of Secretaries (EGoS), Network Planning Group (NPG), and Technical Support Unit (TSU) to strengthen planning and execution
- 17 States/UTs have developed more than 17 customized tools for project monitoring and evaluation.
- 12 States/UTs mandate planning of all upcoming projects on the PM GatiShakti portal.
- 12 States/UTs have enriched data layers with metadata and additional attributes for better decision-making.
- 11 States/UTs utilize the portal to identify and address critical infrastructure gaps.
- 10 States/UTs have integrated District-Level Planning into their infrastructure development strategies.
