IMPACT OF PMKSY IN UTTAR PRADESH

Will the Minister of *FOOD PROCESSING INDUSTRIES* be pleased to state:

- (a) the impact of Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) in Uttar Pradesh during the last five years, the details thereof, scheme-wise;
- (b) the details of various new facilities developed and improved in this regard during the last five years;
- (c) the number of beneficiaries and employment generated in Uttar Pradesh in this regard during the last five years; and
- (d) the amount allocated and released to Uttar Pradesh under the scheme during the last five years, the details thereof, year-wise?

ANSWER

(SHRI RAVNEET SINGH)

(a) to (d): For the development of Food Processing sector in the country including the state of Uttar Pradesh, Ministry of Food Processing Industries (MoFPI) has been implementing the Central Sector Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) scheme. Under component schemes of PMKSY, Ministry provides financial assistance for setting up food processing projects and related infrastructure across the country. The Ministry does not set up food processing industries on its own.

PMKSY is demand driven in nature and applications are invited through Expression of Interest (EoI) from all over India including Uttar Pradesh. The funds are not allocated/sanctioned/released state-wise under any of the component schemes of PMKSY. The proposals received are scrutinized for their eligibility and evaluated based on the criteria fixed as per the extant scheme guidelines. Merit based approvals are given to the eligible proposals based on availability of funds.

Scheme-wise details and year-wise details of the impact of PMKSY in Uttar Pradesh for the last five years are placed at **Annexure-1** and **Annexure-2**, respectively.
