RELEASING PENDING FUNDS FOR KAKINADA SMART CITY

2599. SHRI SANA SATHISH BABU:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the details of total funds allocated, released, and utilized under the Smart Cities Mission (SCM) in the State of Andhra Pradesh during the last five years city-wise and the pending payments to be released, especially for Kakinada;
- (b) the details of completed and ongoing projects under different SCM components, with a special focus on Area-Based Development (ABD) in the State, particularly Kakinada;
- (c) the data on funds received through the PPP route for the State of Andhra Pradesh, citywise; and
- (d) the details of completed, ongoing, and proposed Waste Management Projects, with a specific focus on Waste-to-Energy projects in Kakinada?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS
(SHRI TOKHAN SAHU)

- (a) Four cities *viz.* Amaravati, Kakinada, Tirupati and Visakhapatnam, from the State of Andhra Pradesh selected under Smart Cities Mission (SCM), have been able to claim a total of ₹1,984 crore since inception of the Mission. Amaravati, Kakinada and Visakhapatnam smart cities have claimed full share of the central financial assistance under the Mission. Tirupati smart city has been able to claim ₹392 crore under the Mission. The city-wise details are at Annexure-I.
- (b) Cities under Smart Cities Mission (SCM) are being developed based on Smart City Proposals (SCPs) across various sectors *viz.* smart mobility, Water, Sanitation, Hygiene (WASH), smart governance, smart energy, environment etc., approved by High Powered Steering Committee (HPSC), received from States/UTs. As on 04.03.2025, under SCM, a total of 280 projects amounting to ₹6,589 crore including the projects taken under Area-Based Development (ABD) area in the State of Andhra Pradesh, out of which 235 projects (i.e. 84% of total projects) amounting to ₹5,661 crore have been completed, as per the data provided by cities. The sector wise details of projects are at Annexure II.
- (c) No funds have been received through PPP route project under SCM in the State of Andhra Pradesh.
- (d) Under Swachh Bharat Mission (Urban) 2.0, a compressed biogas plant with a capacity of 20 TPD has been approved for setting up in Kakinada amongst other waste management projects.
