IMPLEMENTATION OF THE DAY-NULM SCHEME

Will the Minister of Housing & Urban Affairs be pleased to state:

- (a) the details of achievements under the DAY-NULM across the seven sub-categories under the scheme during the last three years, State-wise;
- (b) the details of fund allocation from the Central government under the scheme for the last three years, State-wise;
- (c) whether Government has instated awards for top performing States under the scheme, details of award-winning States for the last five years across categories; and
- (d) the index that is used to identify urban poor under the scheme?

- (a) State-wise achievements under the DAY-NULM across all seven components during the last three years (2021-22, 2022-23 & 2023-24) is attached at Annexure I.
- (b) State-wise details of funds allocated under DAY-NULM during the last three years (2021-22, 2022-23 & 2023-24) is attached at Annexure II.
- (c) Systematic Progressive Analytical Real Time Ranking (SPARK) Award has been introduced in 2017 under DAY-NULM to encourage a sense of healthy competition among the States/UTs. From the Financial Year 2023-24, six broad categories of award were introduced. The details of award-winning States for the Financial Year 2019-20 to 2023-24 is attached at Annexure III.
- (d) As per DAY-NULM Mission Document, the target of DAY-NULM has been the urban population identified as below poverty line in urban areas by the States/UTs. The coverage was broadened to include families of disadvantaged groups like SCs, STs, women, minorities, disabled etc. subject to a maximum of 25 percent of the above urban poor population.
