IMPLEMENTATION OF PMNDP PORTAL

291. SHRI KUNWAR RATANJEET PRATAP NARAYAN SINGH:

Will the **MINISTER OF HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the details of the progress made in the implementation of the One Nation One Dialysis initiative through the Pradhan Mantri National Dialysis Program (PMNDP) portal in 2024;
- (b) the detailed data on the establishment of hemodialysis services under PMNDP in PPPs in 2024 particularly in Kushinagar;
- (c) the detailed data on the number of Below Poverty Line beneficiaries under PMNDP in 2024;
- (d) the measures taken to improve the creation of the renal registry in rural areas under PMNDP in 2024; and
- (e) the details of the technological advancements implemented under PMNDP in 2024?

ANSWER

(a) to (e) Pradhan Mantri National Dialysis Programme (PMNDP) launched in 2016-17 for Chronic Kidney Disease (CKD) patients to support in district hospitals in-house mode/Public Private Partnership (PPP) mode under National Health Mission (NHM).Dialysis services are provided in the country free of cost to all the Below Poverty Line (BPL) beneficiaries. Haemodialysis services are provided under the program. Peritoneal Dialysis is also included 2020 onwards.

As on 31st December 2024, PMNDP has been implemented in all 36 States/Union Territories in 748(49 Linked to nearby districts) Districts at 1575 centres with 10850 hemo-dialysis machines and total 317.36 Lakh Hemo-dialysis sessions held.

The PMNDP portal launched on 05 May 2022 is integrated with Ayushman Bharat Health Account (ABHA) ID. The PMNDP portal provides for portability and integration of dialysis centres under NHM with building of renal registry and facilitating portability of dialysis services across the country. The PMNDP portal has the features of global search, generation of waiting list, transfer patients, vacant slots, and slot scheduling modules. The PMNDP portal is currently operational across all the States/Union Territories in the country including rural and urban areas.

The PMNDP portal is also integrated with the Pradhan Mantri Jan Aarogya Yojana (PMJAY) empanelled hospitals in the country. The PMNDP portal has a mobile based application for the dialysis technicians and patients. The dialysis technicians schedule the dialysis sessions in real time. The mobile application has also the provision of data store and forward in the event of internet outages. The patient can view the record of his dialysis session and search the nearby dialysis centres using the PMNDP mobile application.

The Dialysis services are functional in the State of Uttar Pradesh including 20 dialysis machines in Kushinagar district in PPP mode. A total number of 13,227 dialysis sessions have been held in 2024. During 1st January 2024 to 31st December 2024, a total of 60,489 BPL patients have been registered on the PMNDP portal.
