Improvement of pisciculture

2939 Shri Samirul Islam:

Will the Minister of ***Fisheries, Animal Husbandry and Dairying*** be pleased to state:

- (a) the total fund allocated by the ministry for the improvement of pisciculture;
- (b) the new upcoming pisciculture projects for the current financial year, state-wise details thereof; and
- (c) the funds allocated to government of West Bengal for development of pisciculture over the last five financial years, details thereof?

ANSWER

**THE MINISTER OF STATE FOR FISHERIES, ANIMAL HUSBANDRY AND DAIRYING

(a) and (b): The Department of Fisheries (DoF), Government of India accorded approval to the projects at a total cost of Rs.20990.79 crore with the central share of Rs.8926.33 crore during the last 4 years (2020-21 to 2023-24) and in the current financial year (2024-25) under Pradhan Mantri Matsya Sampada Yojana for development of fisheries and aquaculture, including pisciculture with the objective to harness the fisheries potential of States and UTs. State-wise projects approved under the PMMSY during the last four years and in the current year under PMMSY is furnished at Annexure-I.

(c): The DoF, MoFAH&D, GoI under PMMSY has approved the proposals received from the Government of West Bengal at a cost of Rs.544.38 crore with central share of Rs.225.54 crore during the last two years and in the current financial year. The Government of West Bengal has not submitted any proposal under PMMSY during 2020-21 and 2021-22. Out of the approved central share, Rs.50.76 crore has been released to the Government of West Bengal during 2022-23 and the State has reported utilization of Rs.37.85 crore.

Further, a mother sanction of Rs.50.00 crore have been issued to the Government of West Bengal during 2024-25. However, the Government of West Bengal has utilized only Rs.1800/- during 2024-25. The detailed activities approved for pisciculture in the West Bengal during last four years and in the current year is furnished at Annexure-II.
