**CENTRAL ASSISTANCE FOR SOCIAL DEVELOPMENT AND EMPOWERMENT
OF SCs AND STs**

3011. SHRI MALLIKARJUN KHARGE

Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:-

- (a) the details of the various schemes currently being implemented with Central assistance for the social development and empowerment of Scheduled Castes (SCs) and Scheduled Tribes (STs) across the country;
- (b) the details of funds disbursed and utilized under these schemes for the social development and empowerment of SCs and STs during the last five years, State-wise/UTwise, including under the Scheduled Caste Sub Plan (SCSP) and the Tribal Sub Plan (TSP); and
- (c) whether Government has undertaken any assessment of the impact of these schemes on the socio-economic conditions of SCs and STs and, if so, the details thereof?

ANSWER

THE MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT

(a) to (c) The Department of Social Justice and Empowerment (DoSJE) and Ministry of Tribal Affairs (MoTA) are implementing various schemes for social development and empowerment of Scheduled Castes and Scheduled Tribes respectively, across the country. The details of funds released under the major schemes of DOSJE for the last five years including the Development Action Plan for SCs are at Annexure-I.

The details of funds released under the major schemes of MoTA as provided by them for the last three years, State-wise/UT-wise, including the Development Action Plan for STs (DAPST) are at Annexure-II.

DoSJE gets third party evaluation study conducted of its Schemes to assess their impact. Further, some Schemes are separately evaluated by the Niti Aayog.
