Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) the number of consumers who have received grants/subsidies under Pradhan Mantri Surya Ghar Muft Bijli Yojana (PMSGMBY), State-wise including Madhya Pradesh and Haryana;
- (b) the average amount of grant received by each family; and
- (c) the average time taken in processing the grant?

ANSWER

(a) to (c) Under the Pradhan Mantri Surya Ghar: Muft Bijli Yojana (PMSG: MBY), as on 27.01.2025, a total of Rs 4308.66 crore have been released as Central Financial Assistance (CFA) to around 5.54 lakh residential consumers. The state-wise details including the state of Madhya Pradesh and Haryana are given in **Annexure**.

The average amount of CFA released to each of residential consumer under the scheme is around Rs 77,800.

Under PMSG: MBY, the entire process from application to CFA disbursement is online through the National Portal. With all credentials entered correctly on the National Portal, the average time taken in processing the CFA is around 15 days after redemption request made by the consumer.
