## Impact of rising sea levels on coastal villages in Odisha

3067. SHRI SUJEET KUMAR:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) whether Government has identified villages and settlements in Odisha that faced significant risks of submergence due to rising sea levels between 2023 and 2024;
- (b) if so, the details thereof, including the number of affected villages, estimated population at risk, and the extent of land loss during this period;
- (c) whether any rehabilitation or relocation programmes were implemented for displaced coastal communities during 2023 and 2024 and if so, the details of such programmes; and
- (d) if not, whether Government is planning to introduce a structured policy for the long-term protection and resettlement of vulnerable coastal populations in Odisha?

## **ANSWER**

MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (SHRI KIRTI VARDHAN SINGH)

(a) and (b): As per information provided by Government of Odisha, no specific assessment has been conducted regarding the risk of submergence of villages solely due to rising sea levels between 2023-2024. However, the Government of Odisha has identified villages and settlements in Odisha that are at high risk of submergence due to sea erosion/coastal erosion.

An assessment made under Shoreline Management study of Odisha indicate that the coast of Odisha is 50.04% accretive in nature, 12.75% is stable and 37.21% is undergoing erosion (High, Medium, Low).

Following villages have been identified to be at high risk considering the **coastal erosion** during 2023-24:

• In Kendrapara district, 21 villages in Rajnagar Block and 5 villages in Mahakalpada Block have been affected due to sea erosion. Following are the details:

- In Ganjam district, Chhatrapur Block has 12 villages namely, Kanamana, Malikhala, T Berhampur, Upalapati, Rameyapalli, Badaputi, Basanaputi, Kalipalli, Paikapada, P laxmipur, Agastinuagaon, Arjyapalli, in Chikiti Block, Ramayapatana village and in Ganjam block, Podampeta village have been affected by coastal erosion.
- In Puri district, three villages namely Tandahar, Udayakani, and Chhenua under Astaranga Tahasil & three village namely Konark, Gadabangar and Khalakatapatna under Gop Tahasil are affected by sea erosion.

(c) and (d): The Government of Odisha has approved 18 projects for a total amount of Rs. 22.52 crore under the special package for the year 2023-24 to enhance the protection of affected communities and strengthen their livelihoods. The special package includes infrastructure projects like construction of community centre, Community Park, Kalyan mandap, augmentation of electricity lines & substation and educational infrastructure etc. Livelihood support like bio-floc fish farming, Goatery & dairy unit and tailoring unit are also the part of this package.
