STATUS OF PMSGMBY IN ODISHA

307. SHRI NIRANJAN BISHI

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) the number of beneficiaries under the PM Surya Ghar Muft Bijli Yojana in Odisha, district-wise;
- (b) whether a Model Solar Village has been established in each district of Odisha, and if so, the details thereof;
- (c) if not, the reasons for the delay or non-implementation;
- (d) the number of DISCOMs currently operational in Odisha; and
- (e) the total surplus electricity units sold by households in each district of Odisha and the revenue generated from it?

ANSWER

- (a) Under the PM Surya Ghar: Muft Bijli Yojana (PMSG: MBY), as on 24.01.2025, a total of 1,433 residential consumers in the state of Odisha have been benefitted through installation of rooftop solar plants. The district-wise detail is given at **Annexure**.
- (b) & (c) The PMSG: MBY includes a provision to develop one model solar village in each district of the country by selection in a six months challenge mode as per operational guidelines issued by the Ministry on 09.08.2024. After completion of the challenge mode, the model solar villages will be established by the state.
- (d) There are four number of DISCOMs currently operational in Odisha.
- (e) As per Odisha State Electricity Regulatory Commission order on “Net Metering/bi-Directional metering & their connectivity with respect to solar PV projects”, there is no provision of selling surplus solar power to the DISCOMs, however, the surplus solar power fed in to the grid can be adjusted against the self-consumption of the residential consumer within the provisions of the said order.
