INVESTMENT IN WIND ENERGY

308. SHRI SANJAY KUMAR JHA

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) whether there is decline in investment in wind energy sector;
- (b) if so, the details of all the fund allocated by Government and any investment made by the private sector;
- (c) the details of funds sanctioned, allocated, and utilised under the "Pradhan Mantri Kisan Urja Suraksha evam Utthaan Mahabhiyan" (PM-KUSUM) scheme during the last three years and the current year;
- (d) whether Government has made any provision in the PM-KUSUM scheme for the farmers belonging to the Scheduled Castes, if so, the details thereof; and
- (e) if not, the reasons therefor along with the time by which it is likely to be achieved?

ANSWER

(a) & (b) No. The investment in wind energy sector is on increasing trend, with an estimated investment of Rs 7770 crore, Rs 15,925 crore and Rs 22,771 crore during FY 2021-22, FY 2022-23 and FY 2023-24 respectively (considering estimated cost of installed wind power project @ Rs 7 crore per MW).

(c) PM-KUSUM is a demand driven scheme. The funds under the scheme are released based on the progress of installation reported by the State Implementing Agencies (SIA) and as per provisions of the scheme guidelines. The details of funds released, during last three financial years and the current year are placed at **Annexure**.

(d) & (e) PM-KUSUM scheme has provision for fund allocation as per the categories. Under Component B and Component C (Individual Pump Solarization), the funds are allocated for General category, Scheduled Caste and Scheduled Tribe farmers. The State Implementing Agencies provide the details of actual number of applications received and installations done by the various category of farmers.
