- (c) the details of central funds granted, allocated, released, and utilized from 2020-21 to date for SHG schemes in Odisha;
- (d) the details of the beneficiaries, including women and persons from Scheduled Castes and Scheduled Tribes, who have been benefitted from the scheme in Odisha, district-wise; and
- (e) the future roadmap to increase the number of beneficiaries under this scheme in Odisha?

(a): The details of Self-Help Groups (SHGs) in Odisha, district-wise, including the number of active SHGs under Deendayal Antyodaya Yojna-National Rural Livelihoods Mission (DAY-NRLM) is given in **Annexure-I.**

(b): The current status of implementation and major achievements under DAY-NRLM in Odisha is given below:

(c): The details of central funds granted/allocated and released/utilized from 2020-21 till 28th February 2025 for NRLM, Mahila Kisan Sashaktikaran Pariyojana (MKSP), SVEP in Odisha are given at **Annexure-II**.

(d): The details of the beneficiaries, including women and persons from Scheduled Castes (SC) and Scheduled Tribes(ST), who have been benefitted from DAY-NRLM in Odisha, district-wise is given at **Annexure-III.**

(e): The Ministry under DAY-NRLM receives Annual Action Plans (AAPs) from States/UTs including that of Odisha which includes physical targets for mobilization of rural poor women into Self Help Groups (SHGs). The Annual Action Plans are approved by the Empowered Committee set up in the Ministry under the Chairmanship of Secretary (Rural Development) for each financial year. The ultimate aim of DAY-NRLM is to cover at least one woman member from 10 crore rural poor households and bring them under the fold of Self Help Groups (SHGs). All households with at least one deprivation as per the Socio-Economic and Caste Census (SECC) database and identified through the process of Participatory Identification of Poor (PIP) and vetted by the respective Gram Sabhas, are the potential target for coverage under DAY-NRLM. This is a continuous process till all the rural poor women under SECC database and identified through the process of PIP are covered.
