- (a) the impact of the Assistance to Pharmaceutical Industry for Common Facilities (API-CF) Scheme on improving the sustainability of pharmaceutical clusters established last year;
- (b) the details of the funds sanctioned and disbursed under the scheme;
- (c) the details of the projects approved under the scheme; and
- (d) whether there has been any improvement in the pharmaceutical quality attributable to the API-CF-supported clusters since its launch, and if so, the details thereof?

(a) to (d): The details of the grant-in-aid sanctioned and disbursed, and projects approved, under API-CF scheme are at Annexure. These would contribute to improving the sustainability of pharmaceutical quality in respect of the scheme-supported clusters that have over a thousand pharmaceutical units, through development of the common facilities approved for testing and training, research and development and effluent treatment, which are at various stages of development.
