#### **ERADICATION OF TB BY 2025**

#### 3467. SHRI S NIRANJAN REDDY:

#### Will the **Minister of HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the progress made towards achieving TB eradication by 2025, including reduction in incidence and mortality rates, along with State-wise data on TB burden and treatment success;
- (b) the implementation status of the Ni-Kshay Mitra initiative, the number of enrolled beneficiaries, and the measures to enhance community and private sector participation;
- (c) the financial allocation and expenditure under the National Tuberculosis Elimination Programme (NTEP) for the last five years; and
- (d) the steps taken to improve TB screening and diagnosis in rural and tribal areas, including the establishment of testing facilities in aspirational districts and introduction of mobile screening units?

# ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SMT. ANUPRIYA PATEL)

- (a) The Government implements National TB Elimination Programme (NTEP) under the aegis of the National Health Mission (NHM). As per World Health Organization's Global TB Report 2024, the incidence rate of TB in India has shown a 17.7% decline from 237 per lakh population in 2015 to 195 per lakh population in 2023, while the TB deaths have reduced by 21.4% from 28 per lakh population in 2015 to 22 per lakh population in 2023. The details of TB cases notified and treated successfully in year 2023 and 2024, is placed at **Annexure-I.**
- (b) Under Ni-kshay Mitra Initiative, since inception, 2,90,887 Ni-kshay Mitra have been registered and 28.17 lakh food baskets have been distributed to 11.93 lakh consented TB patients till 24<sup>th</sup> March 2025. To enhance the community and private sector participation, special awareness activities were taken up by the State/UT Governments and Intensive Information, Education and Communication (IEC) activities through jan bhagidari were conducted to educate the public and raise awareness about Ni-kshay Mitra initiative.
- (c) The financial allocation and expenditure under NTEP for the last five years, are placed at **Annexure-II.**

- (d) Under NTEP, additional provisions are implemented in tribal / hilly/difficult areas, as under:
  - TB Programme Management Unit (TB Units) 1 for every 1 lakh population in tribal, hilly and difficult area as against 1 for every 2 lakhs general population.
  - Microscopy Centres for diagnosis of TB 1 per 1 lakh general population to 1 per 50,000 population in tribal, hilly, and difficult areas.
  - Patients from tribal / hilly / difficult areas are provided an incentive of Rs. 750 (one time) to cover travel costs of patient and attendant.

Further, under NTEP, the key steps taken to address TB in all population (including in tribal, rural areas and aspirational districts) in the country, are as under:

- Targeted interventions in high TB burden areas through State and District Specific Strategic plans.
- Provision of free drugs and diagnostics to TB patients.
- Intensified TB case-finding among vulnerable populations through mobile diagnostic units for reaching out to remote and rural areas.
- Decentralization of TB screening and treatment services to the Ayushman Arogya Mandir (AAM).
- Private sector engagement with incentives for notification & management of TB cases.
- Scaling up of molecular diagnostic laboratories in all blocks to facilitate early TB diagnosis.
- Ni-kshay Poshan Yojana of Rs. 1,000 per month per patient as nutritional support for the entire duration of treatment.
- Intensified Information, Education & Communication (IEC) interventions to reduce stigma, enhance community awareness and improve health seeking behaviour.
- Provision of TB Preventive Treatment to contacts of TB patients and vulnerable population.
- Tracking of notified TB cases through Ni-kshay portal.
- Provision of additional nutritional support to TB patients and household contacts under Nikshay Mitra initiative.
