SWAMITVA SCHEME IN THE NIRMAL DISTRICT OF TELANGANA

3613. SHRI S NIRANJAN REDDY:

Will the Minister of PANCHAYATI RAJ be pleased to state:

- (a) the details of funds allocated and utilized under the Survey of Villages and Mapping with Improvised Technology in Village Areas (SVAMITVA) Scheme during the last three years, State-wise/UT-wise details thereof;
- (b) the total area covered under the drone survey during the last five years, State-wise/UT wise, if so, the details thereof; and
- (c) the details of current status of the implementation of the SVAMITVA Scheme particularly in the Nirmal district of the State of Telangana?

ANSWER

(a) Funds under the SVAMITVA Scheme are primarily allocated to the Survey of India for Large Scale Mapping (LSM) using drones and establishing Continuous Operating Reference Stations (CORS) in participating States/Union Territories. The following funds have been released to the Survey of India to date:

CORS	₹ 116.54 crores
LSM	₹ 257.93 crores

Additionally, ₹40 crores have been released to the National Informatics Centre (NIC), through NIC Services Incorporated, to support the National Project Monitoring Unit (NPMU), enhancements to the Spatial Planning Application 'Gram Manchitra', central infrastructure, and other technical and software requirements.

Funds are also released to States/Union Territories for Information, Education, and Communication (IEC) activities and the establishment of State Project Monitoring Units (SPMUs). State-wise details of funds released for IEC and SPMU are at Annexure 1.

(b) As of the current date, drone surveys have been completed in 3.20 lakh villages under the SVAMITVA Scheme. Based on available data regarding the average abadi (inhabited) area per village, the estimated total area covered by these surveys is 68,122 square kilometers. State and Union Territory-wise details are provided in Annexure 2.

(c) The State of Telangana signed a Memorandum of Understanding (MoU) for the implementation of the SVAMITVA Scheme on 19th April, 2022. The State initiated a pilot survey in five villages: Adilabad (Adilabad district), Malkajgiri (Ranga Reddy district), Rangareddy (Ranga Reddy district), Jangaon (Jangaon district), and Kamareddy (Kamareddy district), where existing revenue or cadastral records were unavailable.

Telangana has subsequently decided not to extend the SVAMITVA Scheme beyond these five pilot villages. Consequently, the scheme has not been implemented in the Nirmal district of Telangana.
