IMPLEMENTATION OF NMNF AND PKVY

3860. DR. VIKRAMJIT SINGH SAHNEY:

Will the Minister of Agriculture and Farmers Welfare be pleased to state:

(a) whether it is a fact that Government had allocated ₹ 459 crore for National Mission on Natural Farming (NMNF) and spent only ₹ 42.30 crore in 2023-24;

(b) if so, the reasons therefor;

(c) the details of the fund allocated and spent under Paramparagat Krishi Vikas Yojana (PKVY) in last five years to promote cultivation and post-harvest of organic farming, yearwise, activity-wise, State-wise and district-wise for Punjab;

(d) whether Government is planning to provide direct monetary incentives in cash to the farmers who are practicing organic farming; and

(e) if so, the details thereof, if not, the reasons therefor?

ANSWER

THE MINISTER OF STATE FOR AGRICULTURE AND FARMERS WELFARE (SHRI RAMNATH THAKUR)

(a) & (b): In 2023-24, ₹459 crore was allocated for National Mission on Natural Farming (NMNF) at the Budget Estimate stage. The Union Government approved NMNF in 2024-25 (November 2024) for 2024-25 and 2025-26. The allocation for 2023-24 was reduced to ₹100 crore at the Revised Estimate stage. Out of the ₹100 crore, ₹30.19 crore was spent in 2023-24 on awareness generation programs, training and outreach, capacity building, and other related initiatives.

(c) to (e): The Government has been promoting organic farming through Paramparagat Krishi Vikas Yojana (PKVY) in all States/UTs except North Eastern States. Under this scheme, financial assistance of ₹31,500 per Ha over 3 years is also provided for organic clusters, out of which, ₹15,000 per Ha is provided directly to farmers through Direct Benefit Transfer (DBT) for on-farm and off-farm organic inputs. One farmer can avail assistance for a maximum of 2 Ha area under the scheme.

Under PKVY, the allocated fund is utilised for taking up activities as per the operational guidelines including capacity building, certification, awareness & training camps of organic farming, demonstration & adoption, post harvest management, storage & marketing of organic production, value chain development, market linkages, etc. The year-wise & State-wise fund allocated and released in the last 5 years (2019-20 to 2023-24) is given at Annexure-I.

The State Government of Punjab has informed that PKVY scheme is implemented in all 23 districts of the State. The District-wise fund utilised, as informed by the State Government of Punjab, in the last 5 years (2019-20 to 2023-24) is given at Annexure-II. ₹278.50 lakhs was released in 2024-25 under PKVY scheme to Punjab.
