**PLAN TO INCLUDE RAIGAD UNDER SPRM**

3973 SHRI DHAIRYASHIL MOHAN PATIL:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether Government is considering to include Raigad district, Maharashtra, under the Shyama Prasad Mukherji Rurban Mission (SPMRM), considering the rapid expansion of the Mumbai Metropolitan Region towards Raigad;
- (b) the number of Rurban clusters developed in Maharashtra so far, along with their current status and investment details;
- (c) whether Government is planning to establish new Rurban clusters in Raigad; and
- (d) the steps being taken for the upgradation of rural infrastructure in Raigad district?

**ANSWER**

(SHRI KAMLESH PASWAN)

(a): March 31, 2022, has been declared as the sunset date for the Shyama Prasad Mukherji Rurban Mission (SPMRM). Therefore, inclusion of new clusters does not arise.

(b): Under the **Shyama Prasad Mukherji Rurban Mission (SPMRM)**, Maharashtra has been allocated **20 clusters**. The total approved investment for these clusters amounts to **₹2,713.27 crore**, which includes **₹2,263.27 crore** through convergence and **₹450 crore** under **Critical Gap Funding (CGF)**. The current status of a total of **9,199 works** in these 20 clusters is given below:

- **943 works** are currently **ongoing**,
- **2,523 works** have been **completed**, and
- The remaining **5,733 works** are yet to be initiated.

A detailed cluster-wise investment and work progress breakdown is provided in **Annexure-1**.

(c) & (d): As the mission has been discontinued, the question of establishing new clusters and upgradation of infrastructure does not arise.
