PROMOTION OF FOOD PROCESSING TO DOUBLE FARMER'S INCOME IN PUNJAB

563. SHRI RAGHAV CHADHA:

Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) whether Government has any plans to promote food processing as a means to double farmers' income in Punjab;
- (b) the steps being taken to improve food processing infrastructure in Punjab, and the manner in which Government intend to link it with agricultural growth;
- (c) whether there are any specific schemes or financial support provided to farmers and food processors in Punjab to encourage value addition and reduce wastage; and
- (d) in what manner Government is monitoring the impact of these initiatives on farmers' income and employment opportunities in Punjab?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI RAVNEET SINGH)

(a) to (c): In order to promote and ensure overall development of Food Processing Industries across the country including Punjab, Ministry of Food Processing Industries (MoFPI) has been incentivizing setting up/ expansion of related infrastructure through its Central Sector Umbrella Scheme "Pradhan Mantri Kisan SAMPADA Yojana (PMKSY)", Central Sector "Production Linked Incentive Scheme for Food Processing Industry (PLISFPI)" and Centrally sponsored "PM Formalization of Micro Food Processing Enterprises (PMFME)" Scheme and thereby increasing the income of the farmers. These schemes are not region specific but demand driven.

Under PMKSY, credit linked financial assistance (capital subsidy) is provided to entrepreneurs for setting up of food processing industries with total outlay of Rs 5520 Cr for 15th Finance Commission Cycle.

Under PMFME scheme, financial, technical and business support is provided for setting up / upgradation of micro food processing enterprises. The scheme is operational for a period of upto 2025-26 with an outlay of Rs.10,000 Crore.

PLISFPI is, inter alia, intended to support creation of global food manufacturing champions and support Indian brands of food products in international market. The Scheme is operational for a period from 2021-22 to 2026-27 with an outlay of Rs. 10,900 crores.

These schemes aim towards creation of modern infrastructure with efficient supply chain management from farm gate to retail outlet which includes storage, transportation, value addition, etc., thereby help in providing better returns to farmers and creating huge employment opportunities, reducing wastage of agricultural produce and increasing the processing level.

The details of incentives available under these schemes are at **Annexure-I** and the details of food processing projects sanctioned by MoFPI under the said three scheme in the State of Punjab is given at **Annexure-II**.

(d): Ministry has conducted evaluation study for relevant component schemes of PMKSY. These studies have concluded that the component schemes have largely achieved their objectives with substantial benefit to the farmers and created employment opportunities from assisted projects. The evaluation study of Integrated Cold Chain and Value Addition Infrastructure Scheme under PMKSY, conducted by M/s NABARD Consultancy Limited in Year 2020, has estimated that captive projects under the scheme have resulted in increase in farm-gate prices by 12.38 % and each project is estimated to benefit more than 9500 farmers and to create 600 direct/ indirect employments. Under PMKSY, Ministry sanctioned 52 food processing projects in Punjab, out of these 38 projects are completed. From these completed projects 2,12,845 farmers are benefited and generating employment of 20,557.

<u>The details of assistance available to Micro Food Processing Enterprises under</u> <u>PMFME Scheme</u>

(i). Support to Individual / Group Category Micro Enterprises: Credit-linked capital subsidy @35% of the eligible project cost, maximum ceiling Rs.10 lakh per unit;

(ii). Support to SHGs for seed capital: Seed capital @ Rs. 40,000/- per member of SHG engaged in food processing for working capital and purchase of small tools subject to maximum of Rs. 4 lakh per SHG Federation.

(iii). Support for Common Infrastructure: Credit linked capital subsidy @35% subject to maximum of Rs. 3 crore to support FPOs, SHGs, Cooperatives and any Government agency for setting up of common infrastructure. The common infrastructure will also be available for other units and public to utilize on hiring basis for substantial part of the capacity.

(iv). *Branding and Marketing Support:* Grant upto 50% for Branding and Marketing to groups of FPOs/ SHGs/ Cooperatives or an SPV of micro food processing enterprises.

(v). *Capacity Building:* The scheme envisages training for Entrepreneurship Development Skilling (EDP+): program modified to meet the requirement of food processing industry and product specific skilling.
