**STIPENDIARY EMPLOYMENT TO MEMBERS OF SOCIALLY DISADVANTAGED
GROUPS UNDER DDUGKY IN HIMACHAL PRADESH**

624 DR. SIKANDER KUMAR:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether Government is planning to provide stipendiary employment to members of socially disadvantaged groups including Scheduled Caste (SC) and Scheduled Tribe (ST) through skill training programmes organised under the Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU- GKY) in Himachal Pradesh;
- (b) if so, the details thereof;
- (c) the details of funds sanctioned along with sectors under which trainings were imparted along with placements during the last two years in Himachal Pradesh; and
- (d) whether Government has any concrete strategy to streamline the rural sector across the country?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT

(SHRI KAMLESH PASWAN)

(a) & (b): Under the Deen Dayal Upadhyay-Grameen Kaushal Yojana (DDU-GKY) there is no provision of stipendiary employment. However, DDU-GKY guidelines provide for various financial benefits to the candidates, including SC and ST candidates, such as Boarding and Lodging for Residential Trainees, Post Placement Support, Uniform facility, Food and Transport for Non Residential Trainees, Travel Support, Retention Support, Career Progression Support, Counselling support including medical check-ups for candidates placed in foreign countries, Mobile top-up support @ Rs. 50 per month for a period of 12 months, etc. The detail of the Financial benefits being provided to the candidates under DDU-GKY is given at **Annexure-I**.

(c): DDU-GKY Scheme is a demand driven scheme and funds are allocated to States as per the demands against approved Action Plans. The details of funds released (including for SC and ST candidates) during the last two years and current year to the State of Himachal Pradesh under DDU-GKY is given as under:

(d): To streamline the rural sector across the country, uniform Guidelines and Standard Operating Procedures for implementation of the Deen Dayal Upadhyay-Grameen Kaushal Yojana (DDU-GKY) is being followed across the country. The Deen Dayal Upadhyay-Grameen Kaushal Yojana guidelines provide benefits to the candidates for Boarding and Lodging for residential trainees, Post Placement Support, Uniform facility, Food and Transport for Non Residential Trainees, Travel Support, Retention Support, Career Progression Support, Counseling support including medical checkups for candidates placed in foreign countries, etc. There is also a provision of Special Area allowances in case training centre is located in Special Areas. All these initiatives ensure uniformity in implementation of the Scheme in rural sector across the country.
