100 PER CENT ODF VILLAGES GOAL

730 Shri Golla Baburao:

Will the Minister of **JAL SHAKTI** be pleased to state:

- (a) the number of villages with SC/ST majority population that have been declared Open Defecation Free (ODF) as on date;
- (b) State-wise performance, expressed in terms of percentage, in ODF goals;
- (c) whether Government has strategy to expedite and ensure 100 per cent ODF goals by 2025 under the Swachh Bharat Mission-Grameen;
- (d) if so, the details thereof; and
- (e) if not, the reasons therefor including renewed timelines and strategies?

ANSWER

(SHRI V. SOMANNA)

(a) : Department of Drinking Water and Sanitation does not maintain data on villages with SC/ST majority population that have been declared Open Defecation Free (ODF).

(b) : State/UT-wise, No. of villages declared Open Defecation Free (ODF) as per Integrated Management Information System (IMIS of Swachh Bharat Mission (Grameen) as on 7.2.2025 are give at Annexure-1.

(c) to (d) : Swachh Bharat Mission (Grameen) [SBM(G)] was launched on 2nd October, 2014 with the aim to eliminate open defecation in rural areas by 2nd October, 2019. SBM(G) has been implemented as Jan Andolan. Over 10 crore Individual household Latrines (IHHLs) constructed under Phase-I of SBM(G) and all the villages of the country declared themselves Open Defecation Free (ODF) by 2nd October, 2019. Having achieved the outcome of the ODF, Phase II of SBM (G) is being implemented during the period from 2020-21 to 2025-26, with the focus on ODF sustainability and to cover all the villages with solid and liquid waste management i.e. converting the villages from ODF to ODF Plus (Model).
