#### SHORTAGE OF CNG PUMPS

763 # SMT. SUNETRA AJIT PAWAR:

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether there has been an increase in the number of CNG-run vehicles across the country;
- (b) if so, the details thereof;
- (c) whether the increase in the number of CNG-run vehicles has led to shortage of CNG pumps;
- (d) if so, the details thereof;
- (e) whether it is proposed to open CNG pumps in every district across the country;
- (f) if so, the details thereof and if not, the reasons therefor; and
- (g) the details of CNG pumps opened till date across the country particularly in Maharashtra and State-wise?

#### **ANSWER**

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM & NATURAL GAS (SHRI SURESH GOPI)

- (a) & (b): The year-wise details of the registration of CNG vehicles are at Annexure-I.
- (c) & (d): Establishment of CNG stations is part of development of City Gas Distribution (CGD) Networks and the same is carried out by the entities authorized by Petroleum and Natural Gas Regulatory Board (PNGRB) as per their Minimum Work Programme (MWP). As per the MWP, the authorised entities are committed to establish 18,336 CNG stations across the country by 2034. As on 30.11.2024, the entities have established 7,395 CNG Stations against the pro-rata target of establishing 4,025 CNG stations. The cumulative number of CNG Stations established in last three years in the country is as below: -

(e) to (g): After completion of 12/12A CGD bidding round, PNGRB has authorized 307 Geographical Areas (GAs) covering almost 100% of the mainland area of the country for the development of CGD network.
