**UTILIZATION OF CSR FUNDS IN ODISHA
QUESTION**

848. DR. SASMIT PATRA:

Will the Minister of CORPORATE AFFAIRS be pleased to state:-

- (a) the total amount of Corporate Social Responsibility (CSR) funds utilized in the State of Odisha in the last five years, the details thereof, year-wise and sector-wise;
- (b) the names of the CSR projects that remain incomplete in Odisha, and the reasons attributed to the delays or non-completion of these projects; and
- (c) the sector-wise details of the completed works under CSR projects in Odisha, along with the outcomes and impacts achieved from these projects?

(a): On the basis of annual filings made by Companies in the MCA21 registry, the sector-wise CSR expenditure in Odisha during the last five financial years (FY) i.e. 2018-19, 2019-2020, 2020-21, 2021-22 & 2022-23 is attached as Annexure-I.

(b) & (c): The CSR framework is disclosure based and CSR mandated companies are required to file details of CSR activities annually in the MCA21 registry. However, the completion status of CSR work/projects are not maintained separately. All data related to CSR filed by companies in MCA21 registry is available in public domain and can be accessed at www.csr.gov.in.

Ministry vide notification dated 22.01.2021 has introduced the provisions of Impact Assessment in the Companies (CSR Policy) Rules, 2014 by inserting Rule 8(3) therein which inter-alia provides that every company having average CSR obligation of 10 crore rupees or more in the three immediately preceding financial years, shall undertake impact assessment, through an independent agency, of their CSR projects having outlays of one crore rupees or more, and which have been completed not less than one year before undertaking the impact study. The impact assessment report will be placed before its' Board for review.
