STATUS OF THE PM SURYA GHAR: MUFT BIJLI YOJANA

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) the implementation status of the PM Surya Ghar: Muft Bijli Yojana since launch, Statewise details of registrations under the scheme and commissioning thereof;
- (b) whether any measures have been taken by the Ministry to ensure equitable distribution of benefits to rural and urban households under this scheme, if so, the details thereof; and
- (c) whether the Ministry has any plans to extend/introduce similar schemes for public spaces and commercial buildings as well, if so, the details thereof?

ANSWER

- (a) The PM Surya Ghar: Muft Bijli Yojana (PMSG: MBY) was launched in February, 2024. Since the launch of the scheme and as on 06.02.2025, a total of 1.71 crore registrations and 45.15 lakh applications have been received on the National Portal of the scheme. Further, 8.86 lakh residential households have been benefitted through rooftop solar installations under the scheme. State/ UT wise details are given at **Annexure.**
- (b) The scheme is open for all residential electricity consumers including rural and urban areas of the country, getting electricity supply through grid from respective distribution utilities. To ensure equitable access of the scheme and its benefits, the scheme is being implemented through the National Portal (https://www.pmsuryaghar.gov.in) where a residential electricity consumer from any part of the country willing to install rooftop solar plant can register and avail benefits of the scheme.
- (c) Apart from installation of rooftop solar plants in residential sector, the PMSG: MBY also envisage installation of rooftop solar plants in Government and commercial buildings, however, no central financial assistance (CFA) will be provided to these categories of consumers as installation of rooftop solar plants is financially viable for them even without CFA.
