Government expenditure for libraries in educational institutions

117 Dr. V. Sivadasan:

Will the Minister of *Education* be pleased to state:

- (a) the amount spent by Government during last three years on school libraries under various central schemes, details thereof, year-wise, State-wise and scheme-wise details thereof;
- (b) the expenditure incurred during the same period by States and Union Territories from their own budgets on school libraries, details thereof, year-wise and State-wise; and
- (c) the amount spent by Government during this period on the construction, upgradation, digitisation and operation of libraries in centrally funded higher-education institutions, including Central Universities, IITs, IIMs, IISc and NITs, details thereof, year-wise and institution-wise?

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (c) OF RAJYA SABHA STARRED QUESTION NO. 117 ANSWERED ON 30TH JULY, 2025 ASKED BY HON'BLE MP DR. V. SIVADASAN REGARDING "GOVERNMENT EXPENDITURE FOR LIBRARIES IN EDUCATIONAL INSTITUTIOINS"

(a) & (b): The Department of School Education and Literacy is implementing an integrated centrally sponsored scheme for School education- Samagra Shiksha in the country, which subsumes the three erstwhile Centrally Sponsored Schemes of Sarva Shiksha Abhiyan (SSA), Rashtriya Madhyamik Shiksha Abhiyan (RMSA) and Teacher Education (TE).

Under Samagra Shiksha, one of the key interventions, to enhance the quality of education in schools, is the provision of libraries and books across all levels of school education. It includes providing grant for libraries in government schools from Class I to XII. The vision of this component is to develop school libraries as learning spaces that nurture life-long readers and seekers of knowledge and promote reading ability through relevant, age-appropriate, diverse and engaging books and other reading material.

The fund sharing pattern, under the Samagra Shiksha scheme, between Centre and States is at present in the ratio of 60:40 for all other States and Union Territories with Legislature and 90:10 for the 8 North-Eastern States viz. Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim and Tripura and 3 Himalayan States/UTs viz. Jammu &Kashmir, Himachal Pradesh and Uttarakhand. It is 100% centrally sponsored for Union Territories without Legislature.

The year-wise and State/UT-wise details of the amounts sanctioned by the Government (including both Central and State shares), along with the expenditure incurred by the States/UTs over the last three years for the library component under the Samagra Shiksha scheme, are provided at **ANNEXURE-I**.

Besides the above, consequent to the Budget Announcement 2024-25, a National Digital Library or Rashtriya e-Pustakalaya app was launched on 10th Feb. 2024. It is now equipped with over 2200 books in 23 languages. The app will make books available anytime, anywhere and aims to inculcate reading habits in children and youth. So far, more than 2.4 lakh users have registered, and there have been more than 13 lakh reading sessions.

(c): The National Digital Library of India (NDLI), developed by IIT Kharagpur under the Ministry of Education, is a flagship initiative that offers a unified digital platform providing free access to millions of educational resources, including books, research papers, theses, audio lectures, and videos. With contributions from national and international institutions across diverse disciplines, NDLI supports multilingual access and is available via web and mobile applications, promoting inclusive, self-directed learning across all academic levels.

In alignment with the vision of Atmanirbhar Bharat and Viksit Bharat @2047, the Government of India has also launched the One Nation One Subscription (ONOS) scheme, to ensure nationwide access to high-impact international scholarly content. Covering over 6,300 higher education and R&D institutions, the scheme is fully funded by the central government, requiring no payment from individual institutions. For the calendar years 2025, 2026 & 2027, ₹6000 crore has been sanctioned, with ₹1600 crore already utilized to support research and innovation. Currently, around 4,600 higher-education institutions across the country are actively using the ONOS through its portal.

The details of grants released under Capital Assets Head during the last three years including the grants of Rs.40.00 crores (Rs.30.00 crore under Non-NER and Rs.10.00 core under NER Head) released under "One Nation One Subscription" scheme are as under:

Further, as informed by UGC, no specific grant is provided by UGC under the Head of Central Universities for the construction/upgradation of libraries. However, UGC releases grants under Recurring, Salary and Creation of Capital Assets Heads to the funded Central Universities. Grants under Capital Assets Head are provided for books & Journals, ICT enabled infrastructure for online learning and E-resource, small equipment, laboratories, campus development and other infrastructure etc.
