(a) to (d): Khadi and Village Industries Commission (KVIC) is the designated implementing agency for the Prime Minister's Employment Generation Programme (PMEGP) of Ministry of Micro, Small and Medium Enterprises.

Under PMEGP, the maximum cost of the project/unit admissible for availing loan is Rs. 50 lakh under Manufacturing sector and upto Rs. 20 lakh under Service/Trading sector. The amount of loan sanctioned, Margin Money (MM) subsidy disbursed and estimated employment generated under PMEGP since its inception in 2008-09 till date is given Zone-wise and State/UT-wise at **Annexure**.
